



## Application for Emergency Assistance

Emergency funds have been donated by North Central Michigan College students, employees, their families, and many other individuals who are interested in helping students succeed. When funding is available, grants are provided to meet emergency needs that would otherwise prevent students from continuing their education at North Central.

**The Fund is intended to assist students who have experienced an emergency situation that has caused a temporary financial hardship that would prevent them from attending classes. Emergency assistance is provided only for NCMC students during official semester dates.**

### Terms of Grant:

- Funds can cover emergency needs as determined on a case-by-case basis by the Emergency Assistance Committee.
- Checks will be made payable to the company owed, if appropriate.
- Students must complete the FAFSA and have the results sent to NCMC.
- Grant recipients are strongly encouraged to write a thank you letter to the College Foundation about how the grant money helped them to stay in college, complete their program, and achieve their goals.
- Funds can be awarded one time during a rolling 12-month period.

### Eligibility Criteria: (You must meet all criteria below to qualify)

- I am a degree/certificate seeking student enrolled in the current semester at North Central.
- I am a returning North Central student with a cumulative GPA of 2.0 or higher, or, I am a first-time student at North Central with no GPA yet.
- I have completed a FAFSA.

### Instructions:

- Fill out the Application for Emergency Assistance (attached) completely.
- Submit supporting documentation with this application (i.e. eviction notice, utility shut off notice, car repair estimate, etc.).
